10. STREET LIGHTING – to discuss raising the heights of some lamps and possible new street light in St Leonards Road and Wissey View

St Leonards Street – The Clerk and Cllr Eyres met with the lighting contractor and it was agreed that two lights in St Leonards Street would be raised to improve the spread of light over the area. Wissey View – Cllr Goodrham said that he had spoken to all the residents in Wissey View and that none had any objections to a light being installed in that area, Cllr Eyres said that the lighting contractor advised that the best position for the light would be between numbers 23 and 25 and the column, the Clerk will write to all residents regarding this matter. Raising heights of lamps – Cllr Eyres said that he had been told that the concrete columns in Malsters Close can now be extended using a sleeve to go over the top of the existing columns, the company that made the 1.5 metre extensions have now gone bust, the lighting contractor is to source another manufacturer and come back to the Council with new prices. Cllr Eyres proposed that 1 light in Fir Close and 9 lights in Brecklands be fitted with 1mtre extensions the cost of this would be £130 each, this was seconded by Cllr Frost and all agreed.

11. REPORTS

11.1 District Cllr Mike Nairn

District Cllr Mike Nairn confirmed the Council Tax increases as follows, Band A £3.30, B £3.85, C £4.40, D £4.95, E £6.05, F £7..15, G £8.25 and H £9.90. He pointed out that Brecklands have the lowest council tax in the country. He said that the Clerk should have received a letter from Cllr Charles Carter regarding funding that is available for Sport and Play. The devolution debate is still ongoing.

Cllr Eyres asked if the Clerk could contact Highways regarding the gulley's that need flushing in the village, however District Cllr Mike Nairn pointed out that the Highways department are carrying out this work in the area at the moment.
