1. THE CHAIRMAN'S OPENING REMARKS

The Chairman thanked everyone for coming to the meeting and welcomed the new Parish Clerk. The Cricket Club grant application was received after the agenda was issued but will be discussed during public participation.

3. ACCEPT AND SIGN THE MINUTES

The minutes of the meeting held on 4th October 2018 were accepted as a true and accurate record, this was proposed by Cllr Goodrham, seconded by Cllr Frost and 6 agreed. The Chairman signed the minutes.

4. TO RECEIVE DECLARATIONS OF INTEREST

Cllrs S. Eyres and J. Marston both declared an interested in Cricket Club grant

5. PUBLIC PARTICIPATION

Cricket Club grant received from Robin Yates. No other grant has been applied for regarding the heating system however they have approached Breckland County Council for a grant towards some equipment. The total amount to have the main roof insulated and to install proposed heating system will be around £7,000. The grant to Mundford Parish Council is for half of this at £3,500. This is to be discussed further by the Parish Councillors during the December meeting.

A query was raised around the use of the Cricket Club car park by the Football club. Robin confirmed this can be used by the football club but the Cricket Club attendees will need to have priority for any spaces.

N. Enderby provided an update on the drainage system on Swaffham Road. Due to the recent heavy rainfall the gullies are still overflowing and believes the previous work to clean the drains was insufficient and hasn't fixed the issue. N. Enderby has written to highways again and awaits a response.

Chairman J. Musgrove confirmed the drains are overflowing outside the Parish Council office and has taken photographs and will pass these on to Highways.

6. MATTERS ARISING

6.1 Outstanding Highway Matters

- Pig Sty Lane ditch and footbridge Council are denying all knowledge that they have been anywhere near this or carried out a survey.
- Swaffham Road met with Highways and awaiting invoice to increase the footpath and this has been promised by 12th December. Estimated costs around £4,000 to £5,000 and Mundford Parish Council will then make an application for a grant.

6.2 Village Footpaths and Verges – to discuss outstanding matters and actions taken

- 44 The Lamas several complaints received as the footpath is greatly reduced. Cllr S. Eyres and Chairman J. Musgrove will approach the owner again. If this is still not cut back the Parish Council Gardener will cut the face of the hedge back to the rear of the pavement. This was proposed by Cllr T. Fox and seconded by Cllr D. Goodrham and all agreed.
- Rosemary Cottage all works now completed.
- New item Culford House hedge is overgrown and sharp thorns are present due to rose bush. Chairman J. Musgrove will speak to the owner.

• New item – Swaffham Road – grass needs cutting once trees have been cut back as obstructing pathway. Rear of The Crown car park.

6.3 Allotments – to discuss (if any) outstanding or future matters

No interest in the two vacant allotments and this will be put on the notice board. Costing provided for the purchase of two new water tanks which will hold 1,000 litres of water. Chairman J. Musgrove proposed purchase of the water tanks and this was seconded by Cllr T. Fox. All agreed.

6.4 Handyman/Gardener – update on outstanding and future projects

The gardener and Cllr S. Eyres have completed work on the school hedge. The notice board is beyond repair and needs to be replaced. A price is to be obtained. Cllr S. Eyres does not believe the notice board should be used to display people's professions and should only be used for advertising events which are taking place within the village.

6.5 Mundford Post Box – update

Cllr S. Eyres has spoken to the postman for an update on when the post box will be in use. This is currently being investigated and someone will get back with an answer within 7 - 10 days. (Subsequent to the meeting the post box has been put into operation).

6.6 Remembrance Day Service at the War Memorable Sunday 11th November 2018

The boards to display the laminated Roll of Honour have been received. Depending on the weather they will either be displayed on the boards or mounted on ply wood posts. The boards will then be sent to Mundford Primary School for them to display and will finally be sent to the Church for a period of time. Five plastic poppies have been obtained and will be displayed on the lamp posts around the memorial. A donation of £25 will be provided to the Royal British Legion.

A Warrant Officer will be taking the service on the day as no availability from the local churches.

6.7 History of Mundford Book – update

All books have now been sold. Three orders have been received. Chairman J. Musgrove proposed a further reprint of 25 copies and this was seconded by J. Marston. All agreed. Cllr B. Ellis will organise reprints.

6.8 Bulb Planting

This didn't get completed due to poor turnout. The remaining bulbs will be planted on the 10th November at 10am meeting outside the Parish Council office.
