1. Chairman's opening remarks;

The Chairman welcomed everyone to the September meeting, he said that he had taken Cllr and Mrs Morris to put up the SAMS 2 sign and that it would need to be removed on 16th September for the information to be downloaded and then for it to go up again. He said that the Allotment hedge had been cut and was looking better, he thanked the Clerk for delivering and collecting the lawnmower to Lawn Boy in Downham Market and finally he explained that there was an issue with the EDF contract recently signed by the Clerk. It appears that a broker had arranged an account with a different company- using a letter of authority from a previous Clerk, this is being looked into.

2. Apologies of absence:

3. Acceptance and signing of previous minutes;

Proposed by Cllr Pryke, seconded by Cllr Locke and approved by all present with a show of hands The minutes were signed by the Chairman as a true record of the Parish Council meeting held on Thursday 3rd August 2023.

4. Declarations of interest;

Cllr Eyres for item 9.1 Payments and Cllr Morris for item 7.3 Allotments and 7.10 Allotment Tenancy Agreement

5. Public participation;

One lady spoke on behalf of 6 of the members of the public present and several others who could not attend. The group are very upset about the removal of the Flexi Bus service. They are not able to do their weekly shopping by using the Coach Services bus that serves Mundford as they are unable to get to and from the bus stop. They gave the Parish Council 5 letters to pass on to Norfolk County Council on their behalf. The Clerk is waiting on a response from Norfolk County Council regarding this issue. The ladies left at 7.45 pm

A man then spoke about a letter he had send to the Parish Council concerning his thoughts and suggestions for development of the area by the Village Green. Cllr Musgrove pointed out that this was on the agenda under Correspondence and would be added to the next agenda. The other 2 members of the public left at 9.05 pm.

7. Matters arising;

7.1 Outstanding Highway Matters

- The Clerk reported branches overgrowing the sign for Cranwich, but this was deemed to not meet their intervention criteria yet. Though it appears that the branches have been cut back.
- The clerk contacted the Community policing team about the concerns over residents parking on the footpath, they said that this is not illegal, but if vehicles are parking dangerously and causing a hazard, the police could be called. Another suggestion is to contact Highways/ our local County Councillor to ask for advice.

7.2 Footpaths and Verges

- The Clerk contacted the Diocese for the school to ask them to address the issue of the weeds growing out from their front fences. They have removed the weeds and soil. Also, they will look into cutting back the trees that are overhanging the footpath on the Cranwich Road.
- The Clerk also contacted Highways about the weeds outside the school and the Rectory, these do not meet their intervention criteria and the Diocese have said that these weeds are not their responsibility. Cllr Musgrove will contact the Church Warden regarding talking to the Diocese.
- Information from Highways about funding for the NCC grass cutting areas has been received. The meterage for grass verges in Mundford for Urban Grass cutting is 13039. 80m2. The cost for 4 x cuts, based on this year's current RPI for Mundford would roughly be £4,871.67, this figure should be used as a guideline only at this stage. The Clerk to contact them for more information.
- Cllr Eyres pointed out that the Rangers had cut back the trees in Impson Way in 2016, the Clerk contacted them with this information were told: in the past some Ranger work did involve cutting back areas that were not highway authority

land to maintain. A Land Registry search shows that the narrow verge on which the trees are growing is registered to the developer, and therefore responsibility for maintenance of any trees on this verge would fall to them.

- The audio unit has been replaced in the pelican crossing.
- Melanie Badman at BDC has said that she is still in talks with Highways RE this land and if this does not move forward soon, she will arrange a site meeting with some of her people to see what they could do in the mean time for the residents.
- Breckland District Council stated that their Bridges Team that they previously carried out a repair to the footbridge on Pig Sty Lane on a without prejudice basis. However, the bridge remains the responsibility of the landowner."
- Following complaints from residents of The Brecklands and a nasty fall by one of them, the Clerk contacted David Jacklin about the poor state of many areas of the footpath on that estate. A colleague of his assessed the estate and programmed for a couple of areas to be patched, a few kerbs programmed to be replaced and relayed, where necessary, and had any holes in the footway programmed to be filled and made safe. He has added the footways on this estate to the list of schemes on their database as well. He said that he will ensure to keep an eye on the footways, when in the area, to ensure any dangerous parts are amended.
- FP2, the footpath to Lynford Lakes is very overgrown and the Clerk is going to meet Martin Caplin from Norfolk Trails to discuss the area. It is possible that the Parish Council could receive funds to take over the cutting of this area.
- FP1, the footpath off West Hall Drive continues to be an issue, poor grass cutting and areas not cut at all. Breckland will inspect the footpath this week any issues will be identified and addressed with the contractors and landowners.
- Cllr Eyres said that the grass verge opposite Impson Way has not been cut- the Clerk to contact TTSR.
- The broken fencing by the river in the Lammas has been replaced.
- The tree by the roundabout has been reported as it is diseased, this was not deemed to meet their intervention criteria- the Clerk to report this again- concerns over its stability and proximity to the road.

7.3 Allotments

- The previous tenant of plot 12 does not wish to accept the refund.
- The first on the waiting list have agreed to take on plot 12.
- The pull cord on the lawnmower has broken- the mower has been taken to Lawn Boy in Downham Market to be fixed and serviced.
- Plot 15- has been made slightly smaller to allow for a path. The Clerk to contact all current allotment holders to offer a plot swap.
- The next on the waiting list is happy to take on an allotment. Once this has been agreed there will be no-one on the list-the Clerk to add this to the Messenger.
- Cllr Musgrove proposed to order 36 concrete blocks for the base for the water tank, at a cost of £97 with free delivery, this was seconded by Cllr Eyres and approved by all with a show of hands. He will go ahead and order them

7.4 Handyman/Gardener

- Bruce is not well enough to return to work as yet, but will continue to hand in Fit Notes until he is well enough to return
- Cllr Musgrove asked the Cllrs to inform the Clerk of any jobs that need doing, so that she can compile a list for discussion at the next meeting. Jobs suggested were: school hedge, allotment gate and village green bollards and chains and allotment Hut floor.

- The possibility of purchasing a nicer looking fencing for around the trees was suggested- this to be looked into.

- It was decided to add donations to the annual calendar to make sure it is not missed in the future.

7.9 Allotment Tenancy Agreement

• The Cllrs had been sent the amended document ahead of the meeting. Cllr Musgrove proposed adopt the new document, seconded by Cllr Locke and approved by 6 Cllrs with a show of hands.

8. Correspondence

- A resident has asked about bulb planting- it was decided to do this on 14th October- the Clerk to add this to the Messenger, noticeboard and website and Cllr Eyres to speak to Didlington Nurseries about the bulbs.
- The plaques for the planters have been collected and Cllr Musgrove installed them. The Clerk has taken a photo of the one bequeathed by Terence Alderton and sent it to the solicitor of the family.
- James Ingham from UPP has sent this update on the proposed poles in Adeane Meadow; "Thank you for your patience while my colleagues in our build team have been working on this. I've been advised by our build team, following consideration of the resident's feedback and concerns you've kindly shared, Upp won't be proceeding with the proposed poles to service Adeane Meadow.
- Cllr Eyres has suggested that we purchase copies of "The Parish Councillor's Guide" for the Councillors that do not have them. £34.99 a copy. It was agreed to buy 4 copies. The new Cllrs were reminded of the offer of training the Clerk to look into course dates.
- More information has been received regarding Electric Vehicle Charging Points (EVCP's) and it appears that Village Halls can apply for the Plug in Norfolk Scheme: capital installation is free and monthly running costs would be funded for 7 years. Clerk to send this to them.
- A resident has contacted the Parish Council offering a walnut sapling if the Parish Council would like it- also has offered to the Cricket Club and Village Hall. The Clerk to contact him to express an interest.
- A resident has sent a letter to the Parish Council about his proposed ideas for changes to the area around the Village Green, this to be sent to the Cllrs and added to the next agenda.
- Th Clerk told the Cllrs that The Circle of Friends had been sent an email to thank them for all their hard work- they are stepping down from fundraising.
